Thank you for organizing a feis in Eastern Canada! We are so grateful to all those who run a feis in our region. The executive will do everything it can to help support and promote your feis so that dancers in Eastern Canada can continue to thrive in the world of Irish Dance.

REGISTRATION

Feis organizers must submit a form to the IDTAC-ER Feis Registrar to register their feis. This includes existing and new feiseanna, as well as any changes to established feiseanna. The link to the Google form can be found at on our region's website:

We ask that you submit the registration form as early as possible. A feis is considered not registered until payment has been received:

- \$240 for a one (1) day feis
- \$320 for a two (2) day feis
- \$480 for a two (day) feis with a separate feis on each day
- All registration fees are non-refundable

Payment must be sent by e-transfer to idtace.treasurer@gmail.com six (6) months prior to the feis date. Please include the following note when sending the e-transfer: "FEISNAME Registration Fee".

ADMINISTRATION

The IDTAC-ER Feis Registrar will use a multitude of factors when reviewing the Feis Registration Form. It is important that all feiseanna work together to advance Irish dance in Eastern Canada. It follows that the following information will be considered in the review:

- Date of feis
- Location
- Proximity to an existing feis
- Feis cap
- Feis format
 - Etc.

The IDTAC-ER Feis Registrar and the executive reserve the right to deny a feis registration if it does not fall within the scope of established criteria. If a feis registration is denied, an appeal can be made to the Regional Director, whose decision will be final.

Approval may also be revoked if fees are not paid or proof of insurance is not submitted within 30 days of the feis date.

SYLLABUS

The syllabus must be sent to the Feis Liaison for approval before being published. Any offerings that are not part of the Regional Syllabus must be approved by the Regional Director.

INSURANCE

Acopy of proper insurance must be submitted within 30 days of the feis date.

ADJUDICATORS

Please note that a minimum of one third (1/3) of adjudicators must be from outside the Eastern Canadian region. An updated adjudicator/musician contract can be found at on our region's website:

POST-FEIS REPORT

Organizers must submit a short Post-Feis Report to the IDTAC-ER Feis Registrar within one (1) month of the feis using the online form, which can be found on our region's website:

This short post-feis report is used by the executive to measure the success of feiseanna in our region. The information may also be used to help set new organizers up with mentors who have extensive experience in running these events.
